## From My Desk

This four page publication has been produced to encourage residents to both attend the WRA AGM, and to support the association with a membership.

#### The matter at hand

The AGM will be held on November 4th. At that meeting we will need to make a significant decision that will have an effect on the whole Waterside community. The fate of the security service and perhaps the organisation.

#### The history

A short history of security events for WRA would start with Mandurah Industrial Guards (MIG).

MIG provided security for Waterside since the beginning of the WRA security service with four patrols per night.

In December 2016, MIG advised they needed to double the annual fee to cover the cost of WRA security. Three patrols, Monday, Tuesday, Wednesday and four patrols Friday, Saturday and Sunday would be \$36,000 per annum.

The committee could not agree to this proposal and went to the market to find a company that could provide a service to the WRA within the finite budget, which is predicated by the current membership. In May 2016 Perth Security Services (PSS) were appointed on an affordable contract to provide four patrols per night .

This lasted until March 2018 when PSS withdrew from the contract.

Within the month of March 2018 the security contract was taken over by Corporate Enforcement and Security (CES).

Just 4 months later, in June 2018, CES walked away from their contract as it was making a loss.

What has become increasingly clear is that these companies were under quoting in order to gain the business and then unable to deliver. It was also clear to any observer that the annual fees had to increase if the WRA were to continue to supply a reliable service, or the service had to be downgraded.

In July 2018 the committee appointed Armsec as a temporary arrangement to supply services for a period to allow the committee to consult resident members. <u>This is temporary</u> as it is at an annual cost in excess of current income, even for a reduced service of two patrols on Monday, Tuesday and Wednesday and three patrols Thursday, Friday, Saturday & Sunday.

The aim is to establish a patrol of at least 4 per night or three at night and one day patrol 7 days a week 365 days a year. (A majority of burglaries occur in the day time). This level of service will require and increase in fees to about \$200.00 pa at current membership.

The cost of the service is explored for you below.

Without a huge increase in membership, and that is unlikely as some will always stand by and let other carry the cost, the WRA must increase fees to maintain a service at its optimum level. The alternative is a reduced service or none at all.

Together, and with an independent security service we are stronger and more resilient to those that wish to take or destroy what we have achieved in our lifetime. Come on, don't shirk, join WRA.

## Why we need to increase fees

One reason we need to increase the annual fees is because some residents think that as you pay, and cover the cost, they can get a free ride. If your neighbour does not have a Waterside Member sticker on their property, they are likely free loading, or have some excuse for not paying.

The simple fact is, the more people who are willing to join the WRA the less each will need to pay.
